# Terms of Membership Agreement

The Undersigned (hereafter called "Applicant") applies to receive the benefits of membership with Central Texas Electric Cooperative, Inc. ("CTEC"), including electric service, according to the following terms and conditions:

1. Applicant herewith pays a Membership Fee to CTEC in the amount of \$25.00. Applicant agrees that if electric service is discontinued or terminated, any indebtedness to CTEC may be deducted from this Membership Fee. This Membership Fee is non-transferable.
2. CTEC agrees to use reasonable diligence to provide electric service to a point of delivery at Applicant's service location. The electric service contracted for herein is to be provided and taken in accordance with the provisions of this Agreement and CTEC's Tariff. SAID TARIFF IS A PART OF THIS AGREEMENT TO THE SAME EXTENT AS IF FULLY SET OUT HEREIN AND IS ON FILE AND AVAILABLE AT CTEC'S OFFICES IN FREDERICKSBURG, LLANO, MASON AND KINGSLAND, TEXAS. Any Tariff provisions, including rates and charges for electric service, may be changed, including by order or consent of any regulatory authority having jurisdiction thereof whether or not at the request of CTEC.
3. Applicant agrees to purchase and pay for electric service in accordance with CTEC's Tariff. Periodically, CTEC will render to Applicant a statement of services rendered. Applicant agrees to pay the total amount shown on such statement within sixteen (16) days from its date. Payment shall be made to CTEC at its offices in Fredericksburg, Llano, Mason or Kingsland, Texas.
4. Applicant agrees to comply with and be bound by the provisions of CTEC's Articles of Incorporation and Bylaws, as they may be adopted or amended by CTEC's Board of Directors.
5. Applicant warrants that his or her installation (including all conductors, switches, equipment, wiring and protective devices) shall be constructed and maintained in accordance with the American National Standards Institute (ANSI) as well as applicable laws and ordinances. Applicant understands that electricity conducted through CTEC's facilities may be dangerous and agrees that Applicant shall not permit any person on Applicant's premises to contact or come in close proximity to CTEC's facilities.
6. Applicant agrees to grant or secure for CTEC, at Applicant's expense, any rights-of-way on property owned or controlled by Applicant, and to provide suitable space on such premises for installation of facilities where such rights-of-way and space are necessary to provide electric service to Applicant. CTEC'S representatives are hereby granted rights of ingress and egress to Applicant's premises at all reasonable times, without obstruction or impediment, for the purpose of inspection of facilities and/or performing maintenance, system improvements and modifications to the facilities on the premises. If convenient access is not provided, CTEC may discontinue service and remove or relocate its facilities.
7. If Applicant limits access to Applicant's premises with locks on gates, CTEC is hereby granted authority to place a separate CTEC lock to provide access for CTEC representatives.
8. This Agreement shall continue in force from the date service is made available by CTEC to Applicant hereafter until terminated by either party in accordance with law, Public Utility Commission of Texas rules, or service rules and regulations of CTEC.
9. Upon Applicant's failure to make payment or perform any obligation under this Agreement or CTEC's Tariff, CTEC shall have the right to discontinue electric service to Applicant, along with any and all other remedies that may be available by law.
10. Applicant's accounts will be billed in accordance with an Account Schedule developed by CTEC, which may be amended from time to time, showing invoice groupings, rates classifications and other data.
11. This Agreement, together with CTEC's Tariff, constitutes the entire agreement between Applicant and CTEC for the service described herein, and supersedes any and all prior agreements between Applicant and CTEC. Applicant agrees that CTEC, its agents and employees, have made no representations, promises or inducements, written or verbal, which are not contained herein.
