

# Voting at District Meetings

**CENTRAL TEXAS ELECTRIC COOPERATIVE'S DISTRICT MEETINGS** are scheduled to take place in each of the co-op's six districts this June. Elections will be held in Mason, Llano, Comfort and Fredericksburg as part of the process for selecting nominees for directors from those districts.

## Voting In-Person Only

Under the co-op's bylaws, voting by proxy is not allowed at district meetings. Because of the prohibition on proxy voting, a person holding power of attorney for a member cannot use that instrument to vote at a district meeting.



## Joint Memberships

CTEC bylaws provide that a married couple may establish a joint membership, and when they do so, either spouse may vote for the membership. This includes the right to vote at district meetings. However, it is important to note that not all memberships established for married couples are set up as joint memberships. The option belongs to the person or persons filling out the application for service with the co-op. In addition to its effect on voting, joint membership creates specific legal rights with regard to the membership account.

Members can determine whether they hold a joint membership by calling their local co-op office. If a membership is not a joint membership, the spouse of a member will be allowed to vote for the membership (with approved identification) unless the owner of a single membership has indicated in writing that such a privilege is not to be allowed.

## Converting to a Joint Membership

A membership can be converted to a joint membership by written request of the member and execution of a membership

agreement by the member and his or her spouse. These converted memberships must be approved by the co-op's board of directors. In accordance with the bylaws, for a joint membership to be voted as such at a district meeting, the converted membership must be approved on or before the second Tuesday in May preceding the district meeting. To meet this deadline for 2018 district meetings, requests to convert memberships to joint memberships must be submitted so they are received in the co-op headquarters office no later 5 p.m., Tuesday, May 8.

## Firms, Associations and Corporations

Authorized representatives of businesses, community clubs, churches, trusts and similar organizations that hold co-op memberships are permitted to vote at district meetings.

## Call Now To Clarify Voting Status

Questions about the status of a membership account as a joint or individual account can be directed to the CTEC Member Services Department at 1-800-900-2832. In Fredericksburg, the local number is (830) 997-2126. As noted above, a member does have the right to convert an individual membership to a joint membership by completing a new membership application, but because the application must be approved, strict deadlines must be observed. In other circumstances, it may be appropriate to set up a membership as a business or

trust account, enabling an authorized representative of the business or trust to cast the member's vote.

Questions about these arrangements can also be answered by calling the phone numbers shown above.

## District Meeting Voting Summary

- ▶ Members must be present to vote at the meeting. Proxy votes are not allowed.
- ▶ At all member meetings, the spouse of a member will be allowed to vote the membership, whether single or joint, unless the owner of a single membership has indicated in writing that such voting privilege is not to be allowed.
- ▶ Under the bylaws, requests to convert single memberships to joint memberships must be approved by the board of directors at their meeting on the second Tuesday in May. To meet this deadline for the 2018 district meetings, these requests must be submitted to CTEC headquarters no later than 5 p.m., Tuesday, May 8.
- ▶ Call CTEC if you have any questions about voting your membership.

# Gillespie County Introduces Adopt-a-County Road Program

**GILLESPIE COUNTY COMMISSIONERS COURT** has introduced for the first time the Adopt-a-County Road program in an attempt to help maintain the natural beauty of our county landscape. The program is modeled after the well-known Adopt-a-Highway program established by the Texas Department of Transportation. The Gillespie program is focused on county roads whereas the TxDOT program applies to state highways.

The Adopt-a-County Road program officially kicked off November 1, 2017. The application form and all documentation are posted on the Gillespie County website at [gillespiecounty.org](http://gillespiecounty.org). At this time, the county is encouraging and requesting the public (groups and individuals) to adopt and volunteer to pick up litter four times per year along 2-mile stretches of a county road of your choice.

**In return, the county will:**

- ▶ Work with the participating sponsor to identify the specific section of county road to be adopted.
- ▶ Erect at least one sign on the adopted section with participant's name or affiliation.
- ▶ Provide safety information, trash bags, traffic control signs and safety vests.

**How To Apply**

- ▶ Print and complete a simple application from the county website or request one from your precinct commissioner.
- ▶ Submit your completed application to the Rural Addressing Department located in the courthouse basement, room 106, or email it to [litterprogram@gillespiecounty.org](mailto:litterprogram@gillespiecounty.org)
- ▶ Your county commissioner will contact you to get your Adopt-a-County Road program started.

## Smart Grid Technology: Morphing the Future of Electricity


**IMAGINE THE EARLY 1940S IN RURAL CENTRAL TEXAS. A WEARY** housewife wipes beads of perspiration from her brow as the early dawn trickles through the shutters. It's early, but the sweltering heat already owns the morning. Today was to be the day that "a new friend named Electricity" would light up her world and make firing up the woodstove on a stifling hot day a thing of the past. Strange-looking lightbulbs hang in every room, and a shiny, new electrical clothes iron sits on a shelf—just waiting. She is hoping to avoid another day of aching muscles from carrying in loads of wood to keep the stove going long enough to keep the irons hot and get clothes pressed, but it is not to be. As the long day drifts into night—fall that brings small relief from the heat, she reluctantly reaches for a match to light the coal oil lamp for her four children to read by, squelching her disappointment. As if by magic, the lightbulb over her kitchen table suddenly flickers once, twice and then every corner of the room is fully illuminated—more brightly than she had even imagined! The Rural Electrification Act had finally made its way to her area and would drastically change her 1940s world, much like smart grid technology will morph the face of electricity and how it is utilized some 70-plus years later and beyond.

Smart grid technology is an electrical grid that includes a variety of operational and energy measures, including smart meters, appliances, renewable energy and energy-efficient resources. Smart grid technology is a greener technology that provides a transition to a lower carbon footprint. It will enable replacement of our world's aging equipment and will truly modernize the way electricity is produced, transported and ultimately delivered to consumers. Overall, it more effectively integrates and will support greater usage of renewable energy sources such as hydro-, solar and wind power. It will empower consumers with real-time information about their energy consumption, enabling them to better manage usage. By increasing efficiency, electricity costs are projected to be lowered, and the likelihood of burnouts and surges will decrease. Smart grid technology sets a critical foundation for reducing greenhouse gasses and will make the use of electricity greener as a whole on a global scale.

Just as the Rural Electrification Act brought electricity to rural areas and drastically changed the lives of people across the U.S. amidst World War II, smart grid technology is poised to revolutionize how electricity is utilized globally for decades to come. From cities to the countryside, smart grid technology will enable energy providers from large urban electrical power plants to rural electrical co-ops to more effectively plan infrastructure, forecast energy needs, better manage the electric grid, enhance operational efficiencies, and enable delivery of electricity to the right places at the right times. Smart grid technology will allow these entities to increase reliability and meet the ever-increasing demand for electric power worldwide.
